A RESOLUTION OF THE BOARD OF DIRECTORS OF OLIVEHURST PUBLIC UTILITY DISTRICT RESCINDING RESOLUTION NO. 1058 AND ESTABLISHING RULES AND REGULATIONS FOR OPERATION OF FIRE DEPARTMENT

WHEREAS, said Fire Department is operated as a utility division of Olivehurst Public Utility District; and

WHEREAS, the Fire Chief of the Fire Department has proposed a revision of the Rules and Regulations for operation of the Fire Department and has advised the Board that said Rules and Regulations are necessary to improve the management and control of the organization and to assist in carrying out its mission on behalf of the District; and

WHEREAS, the Board has considered the proposed Rules and Regulations.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of Olivehurst Public Utility District does hereby rescind Resolution No. 1058, a Resolution Authorizing Fire Department Rules and Regulations, adopted November 19, 1987.

BE IT FURTHER RESOLVED by the Board of Directors of Olivehurst Public Utility District that the Fire Department Rules and Regulations attached hereto as Exhibit "A" and by this reference incorporated, is hereby approved.

BE IT FURTHER RESOLVED that changes in overall Rules and Regulations of the Fire Department, which affect its overall ability to carry out its mission on behalf of Olivehurst Public Utility District, shall continue to be subject to Board review and approval.
