ORDINANCE NO. 201.2

AN ORDINANCE AMENDING ORDINANCE NO. 201.1, ADOPTED ON JUNE 16, 1994, AND ESTABLISHING A COST RECOVERY PROGRAM FOR THE OLIVEHURST PUBLIC UTILITY DISTRICT'S FIRE DEPARTMENT

BE IT ENACTED, by the Board of Directors of the Olivehurst Public Utility

District as follows:

- 1. Ordinance No. 201.1 adopted June 16, 1994, is hereby amended as follows:
- 2. The purpose of this Ordinance is to establish a mechanism whereby the District's Fire Department may recoup expenses incurred while providing fire protection/rescue services for the community, and to provide funds for the routine operations of the Department.
- 3. A fee schedule is hereby established for services provided by the Olivehurst Public Utility District's Fire Department as follows:

ARTICLE I. BURN PERMITS

A. RESIDENTIAL TRASH BURN PERMITS:

- (1) First Permit (1 year)\$ 5.00

B. SPECIAL RESIDENTIAL BURN PERMITS:

Special Residential Burn Permits shall b issued only by the Fire Chief or his designated appointee. Prior to any burning under the auspices of a Special Residential Burn Permit, the Fire Department must be contacted to coordinate the time and date for the special burn.

C. COMMERCIAL BURN PERMITS:					
(1) Automotive Wrecking Yard (1 year)\$5	0.00

repairing motor vehicles or any other type of motor repair)\$	50.00				
(4) Fireworks Stands\$	50.00				

If the conditions/requirements of any Burn Permit are violated, the Fire Officer will revoke the Permit, and the violator will be required to purchase a second Permit.

Upon a second violation of the requirements of the Burn Permit, the violator will be prohibited from burning for a period of one year.

D. VIOLATIONS:

If Fire Department personnel and equipment respond to the site of an illegal burn, the individual responsible for the illegal burn will be billed for 100% of costs reasonably borne, which will be determined according to rates established in Exhibit "A". Fire Personnel and Equipment Cost Sheet", attached hereto.

ARTICLE II. ANNUAL INSPECTIONS

Fire Safety Control Inspections and State mandated inspection fees shall be as follows:

B. After the third consecutive 911 medical aid response to the same location within a 24-hour time period where no emergency exists, the responsible person will be billed in accordance with the schedule of costs in Exhibit "A", attached hereto.

C. When requested to respond to an auto accident involving drunk drivers, the responsible person or insurance company, will be billed in accordance with the schedule of costs in Exhibit "A", attached hereto.

D. If the Department is dispatched to the same location on more than three 911 calls within 12 months from the date of the first call, where no emergency exists, the responsible person/company will be billed in accordance with the schedule of costs in Exhibit "A".
