## Agenda Item Staff Report

**Meeting Date: February 17, 2022**

### Item description/summary:

OPUD's water and sewer capacity fees each have a clause for increasing the fee due to inflation. The clauses all use the Construction Cost Index (CCI) for 20 cities plus San Francisco published in the Engineering News and Record. Per the CCI for 20 cities plus San Francisco published in the Engineering News Record for the twelve month period of December 2020 through December 2021, the annual increase adjustments for water and wastewater capacity fees for inflation is 7.70% (see attached memo from EPS). My field experience during this period for construction costs is consistent with this data. Each year at this time the Board is asked to approve the fee increase to meet inflation.

### Fiscal Analysis:

Failure to adjust for increases in construction cost will result in a negative consequence. If the OPUD capacity fees don't keep pace with construction cost increases, then the funding available will not be sufficient to build the facilities identified in the respective nexus studies.

**RESOLUTION OF THE BOARD OF DIRECTORS OF

AUTHORIZING ANNUAL CHANGE IN THE CAPACITY CHARGE

**WHEREAS**, the Board of Directors of Olivehurst Public Utility District (OPUD) did, on February 19, 2004 adopt Resolution No. 2065; and

**WHEREAS**, said resolution, by its terms, provides for an annual adjustment, in March, reflective of changes in costs for the construction of the facilities referenced therein by a factor equal to the average of the 20 Cities and the San Francisco Construction Cost Index as reported in the Engineering News Record for the 12-month period ending December of the immediately prior calendar year; and

**WHEREAS**, the Board of Directors did, on February 16, 2006, receive a report from Economic Planning Systems (EPS) outlining the changes in said indexes and recommending an adjustment of the rates established in Exhibit A of Resolution No. 2065 as set forth therein; and

**WHEREAS**, the Board has considered information provided by its staff confirming that actual cost increases for comparable facilities experienced in the District is equal or greater than the cost experience through said index.

**NOW, THEREFORE**, the Board of Directors of the Olivehurst Public Utility District does resolve that, effective March 2, 2006, the rates set forth in Exhibit A to Resolution No. 2065 shall be changed as described on Exhibit A hereof.

**BE IT FURTHER RESOLVED** that the amended rates are required in order to recover for the District the actual costs to repair, replace and reconstruct its utility infrastructure.

**BE IT FURTHER RESOLVED** that, effective March 2, 2006, Exhibit A attached hereto shall be substituted for and attached to Resolution No. 2065 as the currently effective rates until further order of the Board.

**WHEREAS**, the Board has considered information provided by its staff confirming that actual cost increases for comparable facilities experienced in the District is equal or greater than the cost experience through said index.

**NOW, THEREFORE**, the Board of Directors of the Olivehurst Public Utility District does resolve that, effective March 2, 2006, the rates set forth in Exhibit A to Resolution No. 2067 shall be changed as described on Exhibit A hereof.

**BE IT FURTHER RESOLVED** that the amended rates are required in order to recover for the District the actual costs to repair, replace and reconstruct its utility infrastructure.

**BE IT FURTHER RESOLVED** that, effective March 2, 2006, Exhibit A attached hereto shall be substituted for and attached to Resolution No. 2067 as the currently effective rates until further order of the Board.

**RESOLUTION OF THE BOARD OF DIRECTORS OF THE OLIVEHURST PUBLIC UTILITY DISTRICT PROVIDING FOR AND ESTABLISHING A CAPACITY CHARGE FOR THE PLUMAS LAKE SPECIFIC PLAN NORTH ZONE AND NORTH ARBOGA STUDY AREA SEWER COLLECTION SYSTEM AND NECESSARY EXPANSIONS AND IMPROVEMENTS THEREOF**

**WHEREAS**, the Board of Directors of Olivehurst Public Utility District (“District”) owns and operates a Sewer Collection System; and

**WHEREAS**, the District is experiencing tremendous growth and development within an area which has been, or will be, annexed to the District known as the Plumas Lake Specific Plan Area (“PLSP NZ”) and the North Arboga Study Area (“NASA”); and

**WHEREAS**, in order to provide for the sewage collection system requirements of the PLSP NZ/NASA, substantial collection facilities have been, and will be, installed and dedicated to the District; and

**WHEREAS**, the Board of Directors wishes to establish by resolution the capacity fee required for the connection of all customers in the differing cost zones of the PLSP NZ/NASA to its Sewer Collection System; and

**WHEREAS**, the charges established herein are required in order to finance, directly, or through credits to Developers, the necessary construction and expansion of sewerage needed to meet the sewer collection requirements throughout the PLSP NZ/NASA; and

**WHEREAS**, the capacity rates set forth in Exhibit “A” are established for the PLSP NZ/NASA and are approved and authorized in accordance with the provisions of Section 66013, et seq. of the Government Code of the State of California; and

**WHEREAS**, the capacity fee established herein is required to meet the financial reserve needs and requirements of the District and to obtain funds for capital projects necessary to maintain services within the District or to reimburse other persons or entities for their approved costs in construction. Portions of the collection system dedicated to the District are therefore exempt from the requirements of the California Environmental Quality Act in accordance with Public Resources Code Section 21080(b)(8)(C) and (D).

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of Olivehurst Public Utility District that it does hereby establish and approve a sewer collection system capacity fee, payable prior to issuance of a building permit, for connection to its Sewer Collection System within the PLSP NZ/NASA in the amount and under the terms and conditions set forth in Exhibit “A,” attached hereto, which Exhibit “A” shall constitute the District’s Sewer Collection System Capacity Fee Tariff – North Zone.

**BE IT FURTHER RESOLVED** that Sewer Collection System capacity fees set forth in Exhibit "A" are based on the costs of construction of the required improvements and are found reasonable and necessary for the District in accordance with reports and studies prepared by Economic Planning Systems, Inc., dated April 20, 2006, which reports have been duly adopted and approved by the Board of Directors of Olivehurst Public Utility District.

**BE IT FURTHER RESOLVED** that the Board does find that establishment of the Sewer Collection System capacity charges herein is exempt from the provisions of the California Environmental Quality Act under Section 21080(b) of the California Public Resource Code.

**BE IT FURTHER RESOLVED** that said schedule of sewer collection system capacity fee rates and charges shall be subject to the annual inflation adjustment described in Exhibit "A" and shall further be subject to change in base rates determined necessary by the Board of Directors of Olivehurst Public Utility District.

**BE IT FURTHER RESOLVED** that the District may grant credits against the fees otherwise owed (excluding the administrative cost component of said fee) when a person or entity, otherwise obligated to pay said fee(s) has installed collection system facilities upon which said fee is based, in accordance with District rules.

**RESOLUTION OF THE BOARD OF DIRECTORS OF  
OLIVEHURST PUBLIC UTILITY DISTRICT AMENDING RESOLUTION NO. 2115,  
INCORPORATING THEREIN A COMPONENT FOR ADMINISTRATIVE COSTS,  
AND AUTHORIZING 2010 INFLATION ADJUSTMENT**

**WHEREAS**, the Board of Directors of Olivehurst Public Utility District (“District”) did, on March 16, 2006, adopt Resolution No. 2115, establishing a capacity fee for connections to the sewer collection system in Historic Olivehurst; and

**WHEREAS**, said capacity fee is, in accordance with Resolution No. 2115, subject to annual adjustment to reflect the inflationary costs of construction of such facilities as described in Exhibit “A” thereto; and

**WHEREAS**, said capacity fee was based on a nexus study reflecting solely the cost of the collector system pipelines and pump stations installed to provide collector service in Historic Olivehurst; and

**WHEREAS**, the District incurs administrative costs in the management and administration of its capacity fee program including, without limitation, cost of accounting and record keeping, costs of computing and processing any required refunds of refundable capacity charges, and costs of audit and other charges reflecting administration of such fees as required by Government Code Section 660013; and

**WHEREAS**, the District has established and includes an administrative charge of 3 percent of the amount of the capacity fee for all other components of the District’s sewer collection system as well as for its wastewater treatment plant; and

**WHEREAS**, the District has, and is incurring, administrative expenses without recovery therefrom as a component of its capacity fee for connections to the Historic Olivehurst system; and

**WHEREAS**, the Board of Directors of the District wishes to assure that the costs of management and administration of its Historic Olivehurst Capacity Fee Program is consistent with and fully recovers the cost of administration thereof; and

**WHEREAS**, in accordance with Resolution No. 2115, the District is authorized, effective



March 1, 2010, to make an inflationary adjustment to the Historic Olivehurst capacity fees; and

**WHEREAS**, the Board does further find that the inflationary adjustment described in Exhibit “A” hereto is consistent with the currently incurred and anticipated costs of the construction and required expansion of the District’s sewer collector system for the 12 months commencing March 1, 2010; and

**WHEREAS**, the District does further find that the changes in the capacity fee from the Historic Olivehurst sewer collection system are required to maintain adequate financial reserves and fees to ensure costs representing the customer’s prorational benefit from prior construction and future construction of the collector system, including cost and expenses incurred by the District in the administration of such funds and, therefore, said changes are exempt from the requirements of the California Environmental Quality Act in accordance with Public Resources Code Section 21080(b)(8)(C) and (D).

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of Olivehurst Public Utility District that it does hereby authorize this amendment to Resolution No. 2115 to include within said schedule of cost and expenses recovered by the capacity charge, a 3 percent administrative component, consistent with all other administrative costs incurred throughout the District.

**BE IT FURTHER RESOLVED** that the capacity charge established in Resolution 2115 is hereby authorized to be further modified in accordance with the inflationary adjustment authorized in Resolution No. 2115 – that is the average of 20 – Cities and San Francisco Construction Cost Index as reported in the Engineering New Record for the 12-month period ending December 2009.

**BE IT FURTHER RESOLVED** that the schedule of rates and charges set forth in Exhibit “A,” attached hereto shall be the established capacity charges for the Historic Olivehurst collector system for the 12 months commencing March 1, 2010, and continuing until modified by the Board of Directors.

**BE IT FURTHER RESOLVED** that the attached Exhibit “A” shall become part of and modify the schedule of rates described in Resolution No. 2115.

**BE IT FURTHER RESOLVED** that except as specifically modified herein, Resolution No. 2115 shall remain in full force and effect.

**WHEREAS**, Olivehurst Public Utility District (“OPUD”) is a public utility district formed and existing under the provisions of Division 7 of the Public Utilities Code of the State of California; and

**WHEREAS**, The Board of Directors of OPUD has under consideration a change in the District’s schedule of capacity fees for treated water service from the District applicable to the Plumas Lake Specific Plan; and

**WHEREAS**, a capacity rate study was made public and accepted by the Board on January 21, 2010; and has been made available for public review for a period of at least ten (10) days; and

**WHEREAS**, the Board of Directors has, at a public meeting duly noticed, taken public comment upon and considered said Capacity Rate Study, and the budget data and information prepared by OPUD Staff and its Consultant, Economist and Planning System in support of proposed capacity fees; and

**WHEREAS**, the Board finds that an adjustment in capacity fees and charges to the amounts specified in Exhibit “A” hereof is necessary in order to consolidate the fees for both zones of Plumas Lake and secure payment of the costs of capacity already installed, and to be installed on the District’s water system to serve new connections; and

**WHEREAS**, the Board further finds that the consolidated and increased capacity fees are necessary in order to properly replace components of and as necessary upgrade the water system of the District and therefore said increases are exempt from the California Environmental Quality Act (CEQA); and

**WHEREAS**, the Board further finds that the consolidation of the water system serving the Plumas Lake Specific Plan Area, and the associated capacity fee, is necessary and in the public interest in order to reliably serve its customers and charge for the capital costs thereof.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Directors does hereby accept and approve the proposed schedule of rates and charges attached hereto as Exhibit "A."

**BE IT FURTHER RESOLVED** that this increase in water and sewer rates is exempt from CEQA in accordance with the provisions of Section 21080(b)(8) of the Public Resources Code of the State of California, said increase being necessary to recover the costs of past and future costs of construction of the capacity necessary to serve its customers in the Plumas Lake Specific Plan.
