The attached table shows the 2023 to 2024 Building Cost Index (BCI) change for purposes of the annual inflation adjustment for the Olivehurst Public Utility District (OPUD) Fire Protection Facilities Development Impact Fee (Fire Mitigation Fee). Economic & Planning Systems, Inc. (EPS) understands the BCI change is combined with other cost escalation factors to derive the annual Fire Mitigation Fee inflation adjustment.

Table 1 calculates the percentage change in the BCI based on the percentage change in the Engineering News–Record 20-City BCI from May 2023 to May 2024. Applying this methodology, the BCI inflation rate is 3.15 percent.
